# **Terms of Reference Task Group on Mentorship Practices**



### Introduction

At the IRPA Executive Council (IRPA EC) meeting organized during the IRPA Conference in Budapest 1<sup>st</sup> June 2022, Kevin Nelson brought up the idea to create a task group (TG) on mentorship. He felt particularly concerned on how to transfer knowledge and experience from the experienced and senior radiation protection professionals to the younger generation and whether a gap (technological and ideological) may exist between the generations.

Kevin Nelson proposed that the IRPA Young Generation Network take the lead in the management of the TG. The Executive Committee was supportive and approved the creation of a TG. The TG was constituted at the IRPA Young Generation Network (YGN) Leadership Committee (LC) meeting 5<sup>th</sup> July 2022 [1] and a brainstorming meeting took place 12 September 2022 [2].

# Objective

Mentoring can be defined as a support scheme based on a special relationship of reciprocity and good will between an experienced and less-experienced professional to foster the development of the career of the junior professional.

The objectives of the TG include:

(1) Investigate the topic and describe what lies behind the mentoring practices in place within IRPA Associate Societies (AS). A survey form was sent to all AS members to determine whether a mentoring program was present and obtain details on the practices and tools in place and feedback on their mentoring program experience. The survey was open for one month (November 2022) and approximately half of AS members responded. Among the 26 respondents, 5 AS members have a mentoring program in place, 3 AS members have a mentoring program but it was just starting or dormant, 9 AS members wanted a program while 6 AS members did not want a mentoring program.

(2) Based on the AS survey results, develop strategies that could be used to create or enhance existing mentorship programs and publish the results as an IRPA guidance document.

The work of the Task Group is conducted on-line, and no physical meetings are envisaged.

The Exec liaison (or any member of the Task Group) will provide progress reports to the IRPA Executive Council at each Executive Council meeting.
